TPWODL invites Expression of Interest (EOI) from interested parties under Two-Part Open Competitive Bidding Process for "Construction of Section Office at Burla, TPWODL, Odisha"

## 1. Brief Scope of work:

The Brief Scope of Work shall include excavations, brick work, plastering, PCC/RCC work, tiling works, compound wall, structural steel works and miscellaneous general civil works as a Unit Rate Contract. Applicable tender purchase fees and EMB is mentioned in table below:

#### 2. Bid Fee & Timelines:

Interested parties meeting the pre-qualification criteria specified in this document can request for Bid Document and participate in the bidding process by submitting their Expression of Interest (EOI) along with a non-refundable Tender Purchase Fee (Bid Fee) of Rs. 5,900/- by online transfer / RTGS not later than 24<sup>th</sup> December 2021. Request for Bid Document / EOI will not be entertained beyond this deadline. Any payment of Tender Participation Fee by Bidder who does not meet the pre-requisites of EOI within stipulated timeline will not be refunded. MSMEs registered vendors in the State of Odisha shall pay Rs.1,000/- including GST towards cost of tender purchase.

Interested parties to submit details of Tender Purchase Fees deposited along with a covering letter duly stamped and signed by an authorized signatory clearly indicating the Tender Reference Number, your expression of interest for participating in the tendering process and indicating name of authorized person, contact number / e-mail id (mandatory) on Bidder's letterhead to <a href="mailto:sameer.aarya@tatapower.com">sameer.aarya@tatapower.com</a> on or before the due date.

Detailed Bid Documents / Tender Documents (also referred as RFQ) shall be issued through Ariba Platform to the parties who have submitted valid EOI meeting above mentioned requirements as received by the deadline mentioned above.

## 3. EMD / Bid Security (To be submitted only along with bid and not with EOI):

Interested parties to note that Bid Security is NOT required with the EOI. Bid Security of Rs. 2,00,000/- is required to be submitted only along with the Bid (to happen after EOI and issue of Tender Document to valid EOI participants). Bid Security should be in the form of online transfer / RTGS as per details provided. Bids not accompanied by an acceptable Bid Security shall be rejected by the Owner as being non-responsive.

EMD shall be exempted for MSME registered in the State of Odisha. However, Bidder shall be barred to participate in the tendering process for a period of 2 years in case it backs out post award of the contract.

#### 4. Pre-Qualification Criteria:

Interested parties to note that Bidder shall be required to fulfill the following pre-qualification criteria and will be required to submit relevant supporting documents to demonstrate their qualification during the bid submission against Tender document / RFQ (not with EOI).

- a) General: The Bidder or its OEM incorporated in a country sharing a land boundary with India cannot participate in this tender. Declaration by the Bidder / OEM on their letter head in this regard should submit along with the Bid.
- b) Legal Entity: The bidder must be a company registered in India under Indian Companies Act 1956, since last 5 years as on 31st March 2020. The bidder must have GST registration & up-to-date Income Tax Return, PAN Number as on 31st March 2019.
- c) Turnover: The business turnover of the bidder during the last Three financial year ending with 2019-20 should not be less than ₹ 1 Crores (Average) from (as per the last published audited balance sheets / CA certified provisional balance sheet).
- d) Net Worth: The net worth of the bidder in the last three financial year ending on 31st March 2020, (as per the last published audited balance sheet/ CA certified provisional balance sheet) should be Positive.
- e) Technical Capability: The bidder must have successfully undertaken at least the following numbers of similar assignments of value specified herein:
  - One project of similar nature in system integration, not less than the amount Rs. 50,00,000/- (Fifty lakh Only).

OR

> Two projects of similar nature in system integration, not less than the amount Rs. 30,00,000/- (Thirty Lakh Only)

OR

- Three projects of similar nature in system integration, not less than the amount of Rs. 20,00,000/- (Twenty Lakh Only)
- **"Similar Nature"** is defined as Civil Work for Construction of Industrial and Residential Building/Offices including interior works and other associated work in Government / Semi Government / PSU/ Limited Company.
- **f) Blacklisting:** The bidder should not be under a declaration of ineligibility for corrupt and fraudulent practices issued by any Government or PSU in India.
- g) Joint ventures/ Consortiums: Bidder who fulfill the above requirement shall be eligible to apply. Joint ventures/ Consortiums are not accepted.
- h) Manpower requirement: Bidder should have at least one B.E / B Tech (Civil) resource, at least one Civil Supervisor license holder resource
