1.7 Revised Qualification Criteria:

- **1.7.1** The bidder should have average annual turnover of Rs. 10 Lakh. during last three financial years (FY 17-18, FY 18-19, 19-20). Bidder to submit audited balance sheet, profit and loss account in this regard.
- **1.7.2** The bidder should have experience of executing similar nature of works and it should have been executed cumulative order of value Rs. 10 lakhs during last three years Copy of work order / completion certificate to be submitted in this regard
- 1.7.2 Special terms and conditions for *MSME registered in the State of Odisha are as below: -*
- Qualification Requirement of Financial Turnover for MSME registered in the State of Odisha shall be reduced to 20% of the existing criteria.
- MSMEs registered in the State of Odisha shall pay Rs.1,000/- including GST towards cost of tender paper.
- EMD shall be exempted for MSME registered in the State of Odisha. However, Bidder shall be barred to participate in the tendering process for a period of 2 years in case it backs out post award of the contract.

All other terms and conditions of the above tender will remain same as per Tender No TPWODL/MK/O/SER/083.
