1.0 INTRODUCTION:

TP Western Odisha Distribution Ltd (TPWODL) has rallied over 6 years to completely transform the power scenario in the Western part of Odisha. Providing reliable and quality power supply coupled with excellent customer services and boosted by latest technological advances, TPWODL has successfully brought about reforms in the sector and has created a unique service delivery mechanism.

2.0 Intent of Eol:

TPWODL intends for Providing Mobile Health dispensary at selected locations of TPWODL as part of CSR initiatives. TPWODL as a organization & as part of Corporate Social Responsibility is providing and seeks to provide further Mobile Health dispensary at selected locations of TPWODL.

Further to the cause and understanding; as access to basic healthcare services remains a significant challenge in remote and underserved areas, particularly for vulnerable communities. Limited availability of medical facilities, distance to healthcare centers, and lack of awareness often result in delayed diagnosis and treatment. To bridge this gap, it is proposed to introduce a Mobile Health Dispensary (MHD) to deliver primary healthcare services directly to communities at their doorstep.

3.0 Expression of Interest (Eol):

TPWODL hereby invites applications for Expression of interest from interested parties for Providing Mobile Health dispensary services at selected locations of TPWODL. Applicants shall ensure that they meet the Eligibility Criteria as defined at Para 4.0 and Qualifying requirements as defined in Para 5.0 below.

The application shall be submitted as per the format attached (Section-IV) along with relevant supporting documents in support of meeting Eligibility Criteria. TPWODL will consider the applications for suitability in line with the terms and conditions brought out here under and shortlist the bidders based on the information provided by them vide this Expression of interest.

TPWODL may call the parties who have submitted their Expression of Interest for a pre bid discussion regarding the terms & conditions for Mobile Health dispensary services limitations if any and to comply with the queries of the applicants. Finally, techno-commercial and price bids shall be invited from the shortlisted bidders on terms and conditions finalized by TPWODL through Tender NIT for finalization of this assignment and starting of these services through TPWODL E- Tender system (Ariba).

4.0 Eligibility Criteria:

Bidders who meet following requirements will be considered as successful bidder, including as follows:

- The bidder shall be a **Company/Society/Trust/Partnership Firm and should be registered in India with relevant act**, such as a Company (Companies Act 2013/1956) Partnership Firm (Indian Partnership Act 1932 /Limited Liability Partnership Act 2008), Society (Societies Registration Act 1860) or a Trust (Indian Trust Act 1882) and its amendments thereof. No bidder can place Expression of Interest more than one in any form.
- **In case the Bidder is an NGO/Trust, the entity must possess an Unique ID Number through registration in the portal NGO-DARPAN of NITI Aayog.**

5.0 Qualifying Requirement and documents to be submitted along with EOI:

Qualification of bidder will be based on meeting the qualifying criteria specified below regarding bidder's commercial and technical credibility.

The bidders are required to furnish the following documents to assess the capacity and capability of the bidder.

- Bidder must provide proof of having an average turnover of Rs. 50 lacs during the last three consecutive financial years. (FY 23-24, 24-25 & 25-26). Bidder to provide UDIN based CA certificate / balance sheet as proof of the same.
- The bidder should have experience in operation, maintenance of minimum 2 nos of Mobile Health Dispensary per year for any Govt. Organization / Utility/Companies/Unit across India.
- At least two (02) Performance Certificate by any Discoms / PSUs / Reputed companies is to be submitted. The services rendered against these issued certificates should be completed in last 07 years from the date of bid submission. In case the bidder has got previous association with TP Discoms for similar services, performance feedback of the same will be solely considered irrespective of the performance certificate issued to bidder's other customers.
- Bidder should not be blacklisted by any Govt. Organization / Utility/Companies unit across India. Bidder to provide the self-undertaking for the same.
- Bidder should have valid GST No, PAN No.

- TPWODL reserves the right to carry out capability assessment of the Bidders and TPWODL decision shall be final in this regard for selection/rejection of any bidder without assigning the reasons thereof and preference will be given to the Bidders who have worked with Govt. The bidder shall submit all necessary documentary evidence to establish that the bidder meets the above.

Note- In case of MSME, copy of undertaking with MSME registration certificate shall be submitted.

SECTION-II- General Information and brief scope of work for this MHD Services-

1. Operation of Mobile Health Dispensary in Deogarh, Bhawani Patna, Balangir, Nuapada District inclusive of Operational costs of Mobile Health Dispensary such as Staff and their accommodation costs, vehicle cost inclusive of fuel and Consumables such as medicines and stationery.
2. Staff & other Requirement for the project is as follows – includes 1 MBBS, 1 Pharmacist, 1 female attendant (Nurse), 1 driver with their accommodation & Mobile Van.
3. The Mobile Health Dispensary will provide health check-up and medicine to beneficiaries from remote villages of Deogarh, Bhawanipatna, Balangir, Nuapada district as scheduled by the CSR team of TPWODL. The working hours excluding time for travel to villages would be 10:00 AM to 5:00 PM from Monday to Friday and 10:AM to 12:30 on Saturday considering it as a half day. Public Holidays and Sundays will be holidays which would be mentioned in the schedule of each month.
4. The Mobile Health Dispensary is expected to travel a minimum of 100 Kms/day and maximum of 300 Kms/day from Deogarh , Bhawanipatna, Balangir, Nuapada town to target villages as per schedule.
5. The ownership and maintenance of the vehicle to be used would be sole responsibility of the party undertaking the order and the fixed charges for same would be borne by TPWODL.
6. The cost of medicines, stationery and fuel would be billed as per actual consumption. The party would be responsible for maintaining daily OPD Register containing details of the patients treated and details of the medicine distributed, Medicine stock register and fuel logbook.
7. The payment for the services undertaken would be carried out monthly.
8. The party undertaking the order is responsible for carrying out the branding of the vehicle as per the guidelines given by the CSR team of TPWODL and shall bear all costs related to it.
9. The prescription sheet issued and referral sheet issued to the beneficiaries would also have branding and logo as issued by TPWODL CSR team, but the printing would be carried out by the party undertaking the order.
